Terms of reference:

- 1. Develop a system for conscious, consistent and catalytic improvement in the academic, research and administrative performance of the institute.
- 2. Ensure development and application of quality benchmarks/parameters for various academic, research and administrative activities of the institution
- **3.** Facilitate the creation of a learner-centric environment conducive to quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process
- 4. Collection and analysis of feedback from all the stakeholders on quality-related institutional processes
- 5. Dissemination of information on various quality parameters to all the stakeholders
- 6. Organization of intra- and inter-institutional workshops and seminars on quality- related themes and promotion of quality circles
- 7. Documentation of various programmes/activities leading to quality improvement;
- 8. Acting as a nodal agency of the institution for coordinating quality-related activities, including adoption and dissemination of the best practices
- 9. Periodical conduct of Academic and Administrative Audits along with their follow-up activities
- 10.Preparation and submission of the Annual Quality Assurance Report (AQAR) and Self Study Report(SSR) as per the guidelines and parameters of NAAC
- 11. To act as a change agent in the institution so as to ensure quality.

The IQAC should meet at least once in every quarter. The quorum for the meeting shall be twothirds of the total number of members. The agenda, minutes and action taken reports are to be documented and maintained electronically in a retrievable format. The minutes of IQAC meeting(s) and compliance to the decisions taken should be uploaded on the institutional website. The IQAC may create its exclusive window tab on its institutional website for keeping the documents pertaining to NAAC, Peer Team Reports, SSR, Data Templates, AQAR, and Certificate of Accreditation. It shall regularly upload/report on its activities and host the AQAR as well.
